Buyer agrees to provide for this dog's emotional and physical care, including annual physical examinations and recommended vaccinations, nutritious food, preferably (Life's Abundance brand) etc. Seller shall not be held responsible for the development of non-genetically derived faults, diseases, or disorders, which are due to the Buyer's negligence and/or abuse.

A health record of all shots and/or worming will be provided by the Seller. The Buyer agrees to take this dog to a **licensed veterinarian** of their choice within 12 days after picking up for a physical examination. Should puppy/dog be determined to be in ill health at that point, the dog may, upon a signed written diagnosis from said licensed veterinarian, be returned for refund of the purchase price. Seller will buy the puppy back from you for the original amount which is \$**xxxxxx**. No refunds will be given until the puppy is returned. And no refunds will be given without a health examination paper from your vet stating the health issues they have found. The Seller assumes absolutely no responsibility for fees associated with caring for the puppy/dog.

**HEALTH CERTIFICATE:** Seller states that this puppy is, to the best of his/her knowledge, healthy at the time of sale. General health information will be provided verbally by the Seller, which includes information on diet, shots, worming, bathing, and any other treatments given this dog at the time of sale. Buyer will also receive a health certificate for the puppy from the vet.

Registration papers will be provided to the Buyer from the Seller. Buyer is required to fill in their information according to the directions on the registration paper. Buyer is also responsible for all fees in order to register puppy. **This puppy does NOT come with breeding rights and registration for breeding .**

Should a qualifying congenital defect be identified within the first five years of your puppy's life, we will endeavor to provide a replacement puppy of similar color and sex, subject to availability, within one year of receiving proof of the defect.
